1. Description and Reason for Change

It is with great pleasure that we announce the release of a new standard stage for the IntelliXcap line, designed to work as well as an Extended Stage for integrated environments, in case of requirement (optional accessory; Product Code: 46-8112).

Contrary to before, the upgrade to an Extended version of the standard stage is **now possible on the field** and can be done by a qualified Brooks Life Sciences representative upon demand. Moreover, when activated, the **maximum extension of the stage is now 203mm while before it was 207mm**.

This change will be effective as of **July 1**st,**2021**, and will affect all IntelliXcap units with Serial Numbers equal or superior to:

- IntelliXcap™ 96: 46-8012-212103-25
- IntelliXcap™ 48: 46-8011-202103-04
- IntelliXcap™ 24: 46-8010-202103-05
- Not applicable to IntelliXcap AcoustiX (46-8014)

The new standard stage for IntelliXcap will:


 Allow for a field upgrade, while before the rework had to be done at factory site during setup and testing.

All IntelliXcap units that are equipped with this new stage will be eligible to be upgraded on the field upon demand (the extended stage is an optional accessory) and can have the extended stage activated.




The units that are equipped with the new part are IntelliXcaps with Serial Numbers equal or superior to:


In case of an existing unit, please verify the Serial Number of your device to ensure compatibility before enquiring about an upgrade to an extended stage.
